**2010 Courses**

WAG courses for ASP being organised for 24/26 April. MAG courses being organised for 16/18 April in Darwin. Decided since only two participants in ASP that they be flown to Darwin to conserve costs. SMC suggest that courses for 2010 will cost \$133.00pp due to complexity of courses and course material required for each person. WAG course in ASP will remain at \$50.00 pp as can increase costs for the course as DRW participants paid \$50.00 pp. To be ratified by the BOM.
